

#### INTRODUCTION

The administrative requirements when running a business can be daunting. Because you have the expertise and skills to be a successful dance teacher does not guarantee that you have answers to many of the questions that arise, particularly if you are a sole trader without a mentor or guide to help.

Equally, in a changing environment, many experienced teachers can wonder where to find answers to issues in a fast and sometimes challenging working environment.

This compact overview is designed to direct you to someone or an organisation who may be able to support you with a range of issues that may arise. All of the information is on the NATD website but this can be a quick directory.

**Legal Requirements** for a sole trader are basically financial

Register with HMRC Welcome to GOV.UK
Choose a Business Name for invoices and sales
Keep financial records
File a tax return
Pay a tax bill

#### **Good Practice for Dance Teachers**

- 1) Insurance/Licences
- a) Public Liability b) Personal Medical Insurance c) Personal Liability d) Music licence PRS/PPL.

### 2) Policies

The following are highly recommended for all dance schools, should be personalised to individual schools and easily/readily accessible by the public and all parents/students:

Complaints
Code of Conduct
Data Protection Policy
Health and Safety
Safeguarding
Privacy Notice

## 3) Safeguarding/Health and Safety

#### **Attendance Register**

This should be taken for every class on entry in case of emergency evacuation with emergency contacts which are checked annually

#### Studio Risk Assessment

This must be specific to the teaching space

Personalised Registration Form to include:

**Terms and Conditions** 

Fee payments including late/non-payment

Expected behaviour -respect, mobile phone use, social media

Personal details-dates of birth, emergency contact, allergies/known health issues,

#### **Disclosure and Barring Check**

All active members should have a current DBS, renewable every 3 years. This is not a legal requirement but shows transparency to students and parent.

#### **Safeguarding Training**

All NATD members have a dance focused safeguarding training presentation free of charge with membership. A display certificate is available. Suggested renewal is every 3 years. In addition, a validated Level 2 Course is available for all members via the website portal.

#### 4) Relationships with Parents/Students

Dealing with parents can be a challenging experience especially for a newly qualified teacher working as a sole trader. A few guidelines for any communications:

Always remain calm. You are the dance professional and this is your business. Ensure that all your policies are up-to-date and clear, including regarding any abusive behaviour.

Always make notes of any difficult conversations immediately following an incident noting the date and any witnesses.

Do not contact any parent/student other than for dancing arrangements. Avoid personal, inappropriate relationships, be very wary of social media.

The NATD are here to support you, not just for examination sessions, we are experienced teachers with a wealth of knowledge. If you need to discuss a difficult situation, there will be someone to listen.
